



SPRING HEIGHTS CAMP AND RETREAT CENTER-- RETREAT GUEST COVID-19 RELEASE OF LIABILITY WAIVER

Spring Heights Camp and Retreat Center has put in place known preventive measures to reduce the spread of COVID-19 and other infectious diseases, but cannot guarantee that you will not become infected with COVID-19 while participating in activities or events at Spring Heights Camp and Retreat Center.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I, or others, may be exposed to, or infected by COVID-19 while attending activities or events, and that such exposure or infection may result in personal injury, illness, disability, or death.

I understand that to attend an activity or event I must be free from COVID-19 symptoms. Should symptoms develop while on Spring Heights Camp and Retreat Center property, I will be separated from the rest of the people at camp and must be picked up or depart immediately. I further voluntarily agree that the group that I am with, may monitor me for symptoms of COVID-19 (including but not limited to fever of 100.4 degrees Fahrenheit or higher, shortness of breath, chills, dry cough, sore throat, and muscle aches.)

I will immediately notify Spring Heights Camp and Retreat Center and the retreat/camp that I had been with, if I become aware of any person with whom I have had contact exhibits any symptoms of COVID-19, is advised to self-isolate, quarantine, or has tested positive for COVID-19 prior to, during, or within two weeks after my participation on Spring Heights Camp and Retreat Center.

I voluntarily agree to assume all the foregoing risks, to accept sole responsibility for any injury from COVID-19 to myself or to any other person, including, but not limited to, personal injury, illness, disability, death, damage, loss, claim, liability, or expense of any kind, that I or others may experience or incur in connection with, or participation in Spring Heights Camp and Retreat Center activities or events. On my behalf, and on behalf of participants in my group staying with me, I release, covenant not to sue, discharge, and hold harmless Spring Heights Camp and Retreat Center, their employees, agents, and representatives, from all liabilities, claims, actions, damages, costs, or expenses of any kind arising out of or relating to COVID-19. I understand and agree that this release includes any claims based on actions, omissions, or negligence of Spring Heights Camp and Retreat Center, their employees, agents, and representatives, and whether a COVID-19 infection occurs before, during or after participation on Spring Heights Camp and Retreat Center property.

Extension to known claims: A general release does not extend to claims which the creditor does not know or suspect to exist in the creditors favor at the time of executing the release, which if known by the creditor, must have materially affected the creditors settlement with the debtor.
